Hugh Sanburg, CBB secretary/treasurer, stated that during its April 29, 2019 meeting, the CBB Budget & Audit Committee recommended the budget for FY 2020 in the amount of \$43,351,000 which includes an Authorization Request budget of \$39,892,400, Evaluation budget of \$227,000 and Program Development budget of \$335,000 bringing the total program budget to \$40,454,400. In addition, the committee also recommended \$800,000 for the USDA Oversight budget and \$2,096,600 for the Administration budget.

# **Operating Committee Report**

Operating Committee Chairman Chuck Coffey reported the Operating Committee had met prior to the Executive Committee and noted that most Executive Committee members were present on the Operating Committee call to hear the business conducted. Mr. Coffey noted they received an Evaluation Committee update and the ROI study is in place with Dr. Kaiser who also conducted the study in 2014. The ROI report should be available by summer business meeting.

Chuck Coffey moved and Don Smith seconded to recommend a FY 2020 Cattlemen's Beef Board budget of \$43,351,000 including the program budget recommended by the Operating Committee of \$40,454,400, the administration budget of \$2,096,600 and USDA Oversight budget of \$800,000, to the full Board during summer conference. Motion approved.
