Approve Minutes

Chair Jimmy Taylor asked for a motion and second to approve the April 7, 2023, minutes as emailed.

<u>Trish Dowton moved, and Ryan Moorhouse seconded to approve the September 7-8, 2022, minutes as emailed.</u> Motion passed.

Revenue Projection Update for FY 2023

Chad Smith gave an update on the projected revenues for FY 2023. He noted that CBB FY 2023 revenues based on the projections are on track to meet the FY 2023 budget.

FY 2024 Proposed Budget

Budget and Audit Committee Chair Seth Denbow provided a report on the FY 2024 recommended budget. Mr. Denbow noted that the Budget & Audit Committee met on May 9th and developed a FY 2024 Budget. The Committee recommended a total budget of \$40,400,500 for FY 2024. The total recommended Program Budget was \$37,355,475 and was comprised of the following: total Authorization requests of \$36,244,975, Evaluation Budget of \$270,000, Program Development Budget of \$640,000, and Checkoff Communications Resource Budget of \$200,000.

<u>Jeff Isenmann moved, and Jason Hitch seconded to recommend the FY 2024 proposed budget to the Executive Committee.</u> Motion passed.

Other Business

FY 2023 and Older AR Update

CBB CFO Jeff Lutz gave an update on the Contractor spending against their FY 2023 Authorization Request's. Mr. Lutz reported no issues regarding Contractors exceeding their budgets at the tactic level within their Authorization Request. Mr. Lutz also noted that he will follow up with the committee during the September Beef Promotion Operating Committee meeting and will update the committee on the FY 2023 Authorization Requests. The committee can decide if the budget threshold at the tactic level outlined in the FY 2024 Memorandum of Agreement needs to be adjusted.
